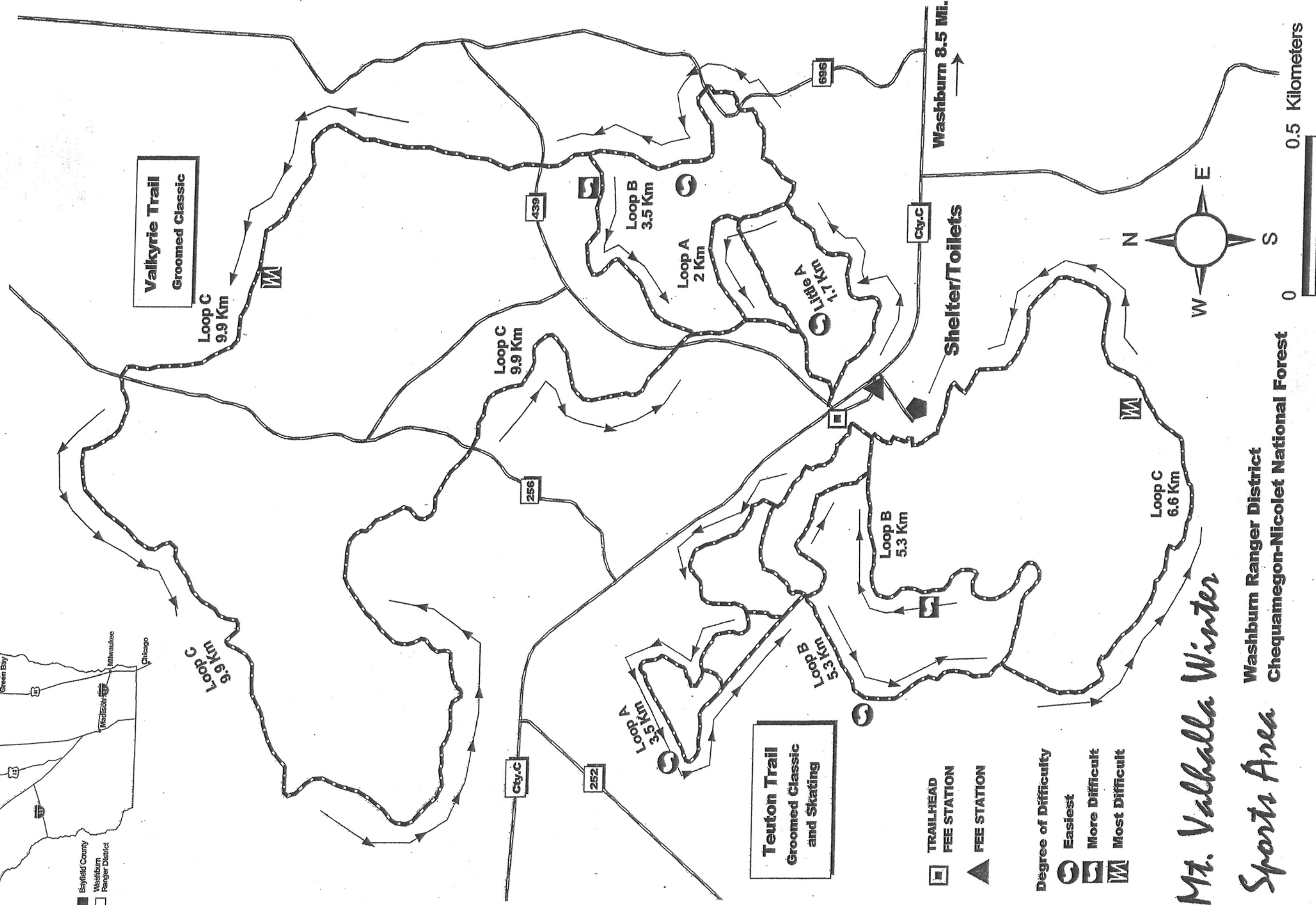

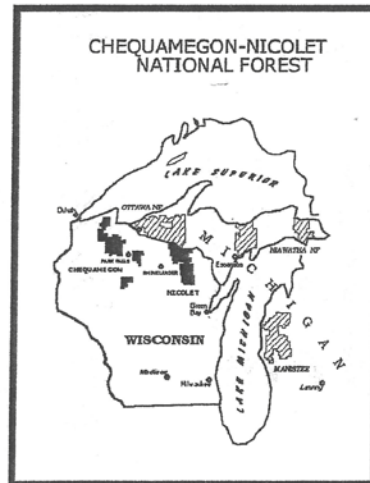

Welcome to Valhalla Recreation Area. Our trails boast a variety of cross country skiing and hiking opportunities, from breathtaking overlooks to gentle winding trails, that can be enjoyed year around.



The Teuton and Valkyrie Trails are a part of the Mount Valhalla Winter Sports Area.

The Teuton Trails follow the rolling morainal hills for approximately 7.3 Mi. This trail system is groomed specifically for classic and skating techniques.

The Valkyrie Trails traverse 6 Mi. through open Red Pine as well as abundant Oak stands. Loop "C" of the Valkyrie Trail that surrounds the Sunbowl provides a breath taking view of Northern Bayfield County during the Fall and Winter. This trail system is groomed for classic X-country skiing only.

Both trail systems are intersected by forest roads and motorized trails at numerous locations. Watch for warning signs.
